### **Spillway Repair Report:**

We recently hired a new Engineering Company, RES Reynolds Engineering Services, LLC. To continue with the spillway repair. They have since surveyed and performed site/field investigations. Once a report is submitted to the SPLA Board, we will hold a scope meeting with the firm to determine on what direction and options we have to repair the spillway. Once we establish a direction, the firm will then submit and application to DEEP for permitting. Once approved by DEEP, the firm will develop construction documents and the project can go out to bid. As those of you who have dealt with the State of Connecticut know, it is hard to give a timeline when construction can start at this time.

#### **Dredging Report:**

We recently hired New England Aquatic Services to start the required steps for the future dredging of the lake.

They have recently finished a sediment survey of the entire lake. This first step was required to determine the amount of sediment that will be removed and the locations.

We are currently working with the Town of Enfield grant writer to assist us with funding both the dredging project and any additional spillway repair costs.

## **Property Committee News:**

You may have noticed tree work being done at all of our community properties. Branches were trimmed and unhealthy trees were removed based on guidance from tree experts. There were four trees removed from 45 Cottage Rd. (Sandy Beach) and two trees removed from 106 Cottage Rd. (vacant lot). Trees were trimmed and loose limbs removed on 121 Cottage Rd. (Upper Beach), 35 Cottage Rd. (Spillway) and 5 Bridges Rd. (Memorial Lot). The property committee is taking a proactive approach to the health of our lake and safety of our community.

#### **Ecology Committee News:**

As in previous years, you may have seen the airboat treating our lake this year. The specialists on the boat are from The Pond & Lakes Connection. They are very knowledgeable about the chemicals and actions required to treat and prevent algae growth and aquatic weeds from strangling our lake. It's been a tough battle with high levels of phosphorus and the results don't always meet our expectations. However, we are taking steps to adjust our treatment, testing schedule and chemical dosages next year.

Per the Health Department high bacteria was also an issue this summer and we had to close upper beach for several days. There are several factors that impact water quality and we are working with other committees to address them.

We have worked with CT DEEP, Pond & Lakes Connection and USDA Wildlife services to discuss impacts to quality of lake water. Major contributors are noted below:

- 1. Geese are a major contributing factor for phosphorus (causes Algae) and bacteria. DEEP suggests 8-10 geese for a lake our size is tolerable. Thus we have a Canada goose mitigation plan and you can read the FAQs at https://shakerpineslake.org
- 2. Fertilizers for lawn's should be non-or low phosphorus We will be making recommendations to the community soon.
- 3. DEEP recommends at least 20-40% of lake shores be plants. We are working to increase this if possible.
- 4. Septic systems could be leaching into the lake and should be addressed by homeowners having their septic's checked and cleaned on a regular basis.
- 5. Dredging the lake would definitely help and there is a study underway.
