A Message from The SPLA Board of Directors

BOATS MUST BE OUT OF THE LAKE BY SUNDAY, OCTOBER, 15 th! Lake drawdown will begin on Monday, October 16 th . The lake should be fully down by Saturday, October 21st. The lake will stay down until the first hard freeze.

PLEASE TAKE THIS OPPORTUNITY TO CLEAN YOUR BEACH! Removing the debris that builds up over the year helps the health of the lake. Excess debris and sedimentation build up over the years cause the lake to become narrower and shallower.





This year the lake experienced many challenges due to the heavy rains and flooding. Algae was an issue as a result of heavy runoff and geese droppings. Please do not encourage or feed the geese Each goose excretes over a pound of droppings per day. Our Lake Association Bi-laws prohibit feeding the geese, as they are contributing to the polluting of the lake and algae growth. Our lake treatment company, Pond and Lake Connection, has worked with us to try and remedy these challenges. They were accessible and responsive within the limits of what DEEP permitting allows. We are happy with the service that they are providing.



Report from the Tax Collector

We have collected \$25,168.73 for this tax year to date. Our current outstanding debt is \$16,607.78 with bills going back to 2016. Tax Warrants have been issued to taxpayers with 3 or more outstanding invoices. If you have received a tax warrant, Please work directly with the State Marshall for payment arrangements.
