Lake Updates

Spillway Repair: We have applied for an informal review with the State DEEP to try to determine what they will require for permitting. We are doing this to try and eliminate costly surveys and reports if we can. We are also actively exploring possible funding sources to help defray the repair costs.

Lake Water Quality It has been a difficult season, State DEEP being understaffed, was extremely slow to issue our treatment permit. The very late permit issuance and the drought has put us behind and allowed the algae growth to get ahead of us. Our lake and many others have suffered for it. Our new treatment company has been very responsive, but it has been an uphill battle. We also had to close off portions of the lake to swimming a few times this summer due to elevated E.coli bacteria readings. Please do not feed and encourage the geese, they are a BIG contributor to this problem. If an area is closed a sign is posted in the problem area, when the sign is removed it is safe to swim. Issues of concern are also posted on our Shaker Pines Lake Facebook Page in real time, if you have concerns look there.

SPECIAL MEETING - SEPTEMBER 27, 2022 BUDGET INCREASE NEEDESD

Last year the Board of Directors reviewed the insurance coverage for Shaker Pines Lake Association, Inc. The Board found that the insurance coverage category was not appropriate for our organization and felt it could put us at risk should a claim be made. Our previous liability insurance premium was \$1,300. Based on discussion with agents and other research the estimated premium was budgeted at \$2,000. Additionally, the Board's review noted that there has been no Directors and Officers insurance in place for the Association and \$1,000 was budgeted as a place holder. The quoted premiums came in significantly higher than anticipated:

Liability coverage quote: \$7,200

Directors and Officers coverage quote: \$2,500


To insure that we (SPLA) continued liability coverage the Board approved and paid for coverage effective July 6, 2022 through October 6, 2022. To continue this coverage and obtain Directors and Officers Insurance, we must have approval of the Association members.

According to our Charter Section 22:

any contract or obligation totaling more than \$3,000 must be approved by a vote of the members at a Special meeting. Because the Board is requesting an increase to \$9,700 for Insurance, a Special Meeting of the Association will be held at the Shaker Pines Fire Station, located at 37 Bacon Road in the Town of Enfield, CT on Tuesday, September 27, 2022, 7:00 p.m., The ballot box closes at 8:30 p.m. **IDENTIFICATION REQUIRED.**

Tax Collector Corner

From July 1 to-date, we have collected \$24,276.21 and our tax deficit is \$17,831.34. The Shaker Pines Lake Association (SPLA) is a "Special Tax District" within the Town of Enfield, governed by all of the local and State of Connecticut tax statutes. SPLA tax bills are sent out in June and due by July 1 (with a 30-day grace period without interest penalty). This year's bills were due July 1 with an August 1 grace period (as July 31 was a Sunday). Payments "received" after August 1 were subject to a 1.5% interest fee per month for both July and August, and subject to 1.5% interest per month thereafter. This information is clearly stated on the tax bills. The SPLA tax collector has tried to simplify the payment process by creating an on-line site which mirrors the Town of Enfield tax site. On this site, tax payors can print out their bills and pay them directly on-line via credit card or e-check for small fees. The site is up to date with interest and fees and past due bills. Note- when paying your taxes, if you have Past Due bills, your payment must be made on the Past Due bill first. In addition, payments are applied to fees and interest first and then tax. If individual outstanding bills exceed three years or amount to over \$1,000, then warrants are issued, and the tax collection is turned over to the State Marshall.

Again, this is a "TAX", not an association fee or convenience fee. There is absolutely "no" flexibility in waiving the tax rules to ignore interest for those who pay their bills past the due date or write their checks on the due date then put them in the mail. And there is no leeway to release liens without having the entire bill paid in full.

We are audited by the State of Connecticut Office of Policy Management and must follow all CT and Town of Enfield Tax Laws!

If you are having trouble paying your SPLA taxes, please contact Jaime Macsata to set up a payment plan to avoid the issuance of liens and warrants.
