CD 1 In the amount of \$83,070.81 matures tomorrow with the interest rates being so low on CD's right now and the spillway cost pending, Lorraine suggested we not renew CD and add cash to capital account.

Lorraine made a motion to not renew CD and put the \$83,070.81 in capital account. Jaime seconded motion. All in favor motion moves.

Jaime Macsata provided the following information regarding the new website.

Contacted Go Daddy and JumpLine for information on our website. JumpLine is the company that holds the code/data for the website. Go Daddy hosts it along with the domain name.

JumpLine they indicated that they don't accept phone calls and everything has to be done through an on-line "chat". So through the on-line chat, I found out that the server our code is on is very old and should be migrated to the newer servers. Although there would be no charge to move the code, they couldn't tell me what the cost would be to maintain the site and upgrade on a staging site.

Jaime Macsata reported she reached out to Go Daddy who recommended two options. I actually spoke to someone on the phone that had access to our account. To create a brand new website we have two options:

1. Ultimate Package - includes unlimited server storage capacity; server site SSL security; back end security - firewall, spam, malware protection; staging site to create new website without having to take old one down first; creation of e-mail.

Cost Ultimate Package - \$240/year (\$20/month) Multi-year discounts offered for new product: 3 year \$467.64 (\$12.99/month) paid up 5 year \$779.40 10 year \$1,558.80

2. Deluxe Package includes 75 gigs server storage capacity; server site SSL security; staging site and E-mail. Does not include back end security.

Cost Deluxe Package - \$180/year (\$15/month):
Multi-year discounts offered for new product:
3 year \$360.00 (\$10.00/month) paid upfront
5 year \$600.00
10 year \$1,200.00

Jaime Macsata made a motion to go with the Go-Daddy 3 year ultimate package plan at a cost of \$467.64 to be paid up front. The plan includes unlimited server storage capacity; server site SSL security; back end security firewall, spam, malware protection; staging site to create new website without having to take old one down first; creation of e-mail. Seconded by Lorraine Creedon.

### Discussion -

We are currently paying now \$86 per year.

Sharon Ledger stated the currently Bob Duga has trouble with jumpline monthly.

Allison Cushing suggested we not go with a package of more than 3 years due to the technology changes. We will pay the jumpline fees until we are ready for Go-Daddy.

Vote to approve budget. Motion made by Lorraine Creedon to accept the current proposed budget. Seconded by Linda Ostapoff.

Dan Smith printed the newsletter this month that will be mailed tomorrow.

Vote was taken all in favor. Proposed budget passes.

Ecology - Leslie Cunningham

Nick at Pond and Lake Connection – we still do not have a permit. Follows up weekly. No treatments can be received without permit to treat.

DEEP is holding up the permit process due to staffing issues and retirements.

Leslie to update Facebook

Ecoli - Town test the lake water monthly and provides results to Leslie. This month the ecoli levels were high which resulted in no swimming is allowed in lake until the lake was retested.

Nick at Pond and Lake Connection confirmed the geese contribute to the ecoli levels being high.

Do not feed the geese. The ecoli levels are high near the pumping station.

Dan Hart who maintains the lowering of the lake, was away and we received a large amount of rain in a short amount of time that required the lake needing to be lowered. If Dan will be away and unable to lower lake if needed he will let Leslie know.

Allison suggested all Board members should be able to be backups if needed.

One day will be allocated for board to go to spillway and see what the process is and how to complete. This will allow board to also understand the repairs that are needed better

Spillway Report -

It still has not been determined if we need wetlands survey. Leslie and Lorraine will reach out to Town Wetlands to discuss. Wanted to put us on wetland agenda

Wright and Pierce quote was \$12k – however, it has been noted that pricing is high and can find someone to do.

Spillway will be discussed at annual meeting. Discuss funding streams.

Actual cost of spillway repairs is estimated to be in the \$130-151K range.

However, we need final plan and to determine if wetlands/survey is necessary before we can begin getting bids.

Insurance Policy – Still being worked on. Hoping to have an answer by end of June 2022.

Lake front homes would be 1 mil and back lots would be  $\frac{3}{4}$  Mil rate.

Reasoning is that larger lot sizes would pay more for taxes.
