Water Testing:

Potability \$95.00 (chemicals and trace metals)

VOC's \$100.00 \*see below.

Collection Fee: \$60.00 Total \$255.00

They will come and collect the water. We need to tell them where to collect from. This price is per one location on the lake.

testing for POPS (Persistent organic pollutants) chemicals mentioned in HRP report: organochloride pesticides including chlordane, dieldrin, toxaphene.
