Leslie Cunningham started off the meeting stating we need 5 nominations for new board members for the 2023-2024 year.

Leslie Cunningham (President), Dan Hart (Vice President) and Lorraine Creedon (treasurer) and Allison Cushing will not be running this time. Many thanks to you all for all your years of servicing on the SPLA board.

Leslie unlocked the ballot box – removed the prior year ballots and then relocked the ballot box. Voting is now officially open.

Article 1: To elect (5) Members of the Board of Directors for a two (2) year term: Nominations:

- Travis Buck nominated Charlie Macsata. Linda Ostapoff seconded the nomination. Charlie Macsata accepted the nomination.
- George Temple nominated Jaime Macsata as Tax collector. Lorraine Creedon seconded the nomination. Jaime Macsata accepted the nomination.

Article 2: Report of Officers and Committee Chairpersons:
Committee Reports –
Ecology - Leslie Cunningham
Spillway Repair Project:

Wright and Pierce are currently working on the project for us. We contracted with Wright and Pierce since we had hired them previously and Stephanie Hubbard was our contact. She was wonderful so we went with them again. Stephanie since has left Wright and Pierce and moved to Maine. The new people we are dealing with are not as reliable as Stephanie.

In September 2023 Leslie and Lorraine had a meeting with DEEP. Lorraine thought there was a wetlands mitigation on file, however it was too old, therefore, a new survey is now required. At that time DEEP stated we would need an individual permit vs a general permit.

Wright and Pierce had a preliminary meeting with DEEP to see if they would accept a general permit, DEEP responded an individual permit will be required. Which we were just notified will cost an additional \$46k.

Wright and Pierce stated if we were to approve the Amendment to the Shaker Pond Dam Spillway Project, they would move forward with obtaining the permits. This would take 6-8 weeks and they would expect to hear back in 3 weeks.

Since this information was just received this week, the committee will need additional time to research this. The committee will be meeting after this meeting to discuss what action needs to be taken. Note: This increase would require a special meeting.

Last summer/fall Linda and Mike Ostapoff submitted a presentation requesting funding from the Town of Enfield. They worked with Nick Hopkins and Matt Despard who then presented to the Town Council requesting \$151,000 funding. They agreed to fund \$75,000 from ARPA funds and \$76,000 from the Town CIF fund. Thank you so much to Linda and Mike for putting this together.

Lake Treatment

We are currently contracted with Pond and Lake Management. They are very responsive, and we are very happy with them.

The treatments we are treating for weeds/algae and the treatments non-toxic. The Geese are a huge problem to our lake. PLEASE DO NOT FEED GEESE!

DEEP recommends hazing them to discourage them from being residents.

New this year DEEP requires all lake front homeowners be notified of lake treatments. Which is why we had to request email addresses to allow Pond and Lake Management to notify homeowners.

Dam Lot – Memorial Park

The board needs to watch, maintain, and repair issues are they are identified.

Currently we have muskrats there that are causing issues. People are fishing on the edge. Kids are also removing rock.

Fence – 119 Cottage Road

This issue has been amicably resolved and all parties are happy.

The is a knotweed at upper Cottage Beach is getting out of control. At the last board meeting, it was discussed that we would ask the landscaper how the knotweed should be managed.

East Longmeadow construction near Jawbrook Reservoir -

There is concern about how the proposed recycling/transfer station for processing of construction and demolition materials will directly feed our lake waters.

We hired an engineer, Victoria Houle, to complete a study, which was presented to the Town of East Longmeadow.

Lisa Lacombe, 143 Cottage Road suggested someone contact the Town of Longmeadow, Wolf Swamp conservation for their opinion on the recycling/transfer station project.

Property Committee –George Temple

Lower Cottage beach lot is very uneven. George will walk the lot with Fred from Plaza Excavating in August to determine how much topsoil would be required to level lot.

Plaza Excavating provided rock for Memorial lot and sand for lower Cottage beach.

- Dan Hart and Leslie Cunningham cleaned up the Memorial lot and distributed the rocks where needed.
- The sand will be spread out in the next couple of days.
- Ann and Wayne Buck cleaned up the upper Cottage beach.

There are picnic tables that need to be repaired.

The swimming sign with life preserver will be re-installed at upper Cottage Beach.

There is a tree growing out of the retaining wall at the upper Cottage beach that runs on SPLA property and the 119 property line. It is not in any danger of falling but should be removed soon. George received a quote of \$800-\$1,000 to have removed.
